Re: Notice of Reduction In Force by Bill Wright, Inc.

Dear Mayor Goh, Chairman Leticia, Ms. Hitchcock and all others interested in said notice:

In accordance with the provisions of and regulations under the Worker Adjustment and Retraining Notification Act (WARN) as set forth under applicable Federal and State law, this will serve to advise the City of Bakersfield, County of Kern, WARN Act Coordinator for the Employment Development Department and Local Workforce Investment Board that Bill Wright, Inc., which does business as Bill Wright Toyota ("Bill Wright") plans to close its current dealership location at 5100 Gasoline Alley Drive, Bakersfield, California on or about September 28, 2020, or within approximately 14 days of said date. The reason for the closing of this dealership location is the sale of the assets of the business operations to another business entity. In conjunction with the closing of this location, it is anticipated that all of the Bill Wright employees will permanently lose their jobs with Bill Wright, though some of these individuals may be hired by the new entity purchasing the assets of Bill Wright who will continue dealership operations after the sale.

It is anticipated that these layoffs/terminations caused by the closing of the Bill Wright dealership location will result in permanent terminations. It is also anticipated that that employee separations will commence as of September 28, 2020 and/or within 14 days of this date.

These layoffs/terminations will affect a total of approximately one hundred and fifty (150) employees in various positions within Bill Wright's facilities. A copy of the specific position and number of employees affected is attached to this notice. Individual employees affected by this action have also been notified via individual letters.

There are no applicable bumping rights in existence, nor are there any unions representing the affected employees.
